## **Support the Medical Nutrition Therapy Act**

The Medical Nutrition Therapy Act was introduced in the 117th U.S. Congress in May 2021 (H.R. 3108 | S. 1536). This legislation, which is championed by the Academy of Nutrition and Dietetics, a Defeat Malnutrition Today member, would allow Medicare beneficiaries to access the care they need by providing coverage for Medical Nutrition Therapy for a variety of chronic conditions under Medicare Part B. The bill was introduced by Sens. Susan Collins (Maine) and Gary Peters (Mich.) and Reps. Robin Kelly (III.) and Fred Upton (Mich.). Access to MNT is especially critical for communities of color that suffer from chronic disease health disparities driven by reduced access to care, healthy foods and safe places to be active.

### The MNT Act amends the Social Security Act to:

- Provide Medicare Part B coverage of outpatient MNT for prediabetes, obesity, high blood pressure, high
  cholesterol, malnutrition, eating disorders, cancer, gastrointestinal diseases including celiac disease, HIV/AIDS,
  cardiovascular disease and any other disease or condition causing unintentional weight loss;
- Authorize the Secretary of Health and Human Services to include other diseases based on medical necessity;
   and
- Allow nurse practitioners, physician's assistants, clinical nurse specialists and psychologists to refer their patients for MNT.
